

THE REALTOR® DUES FORMULA

The National Association of REALTORS® requires a specific formula for dues that is applicable nationwide and is not optional. Any Designated REALTOR® (usually the owner) for the firm who belongs to REALTORS® must pay for any licensee in that firm who does not become a REALTOR® (non-member assessment).

Many companies have office policies that require the real estate licensee to decide if he/she wants to join or to reimburse the company for the assessment.

There are no separate fee structures for part-time agents, seasonal agents or licensed professional assistants. Similarly, there are no refunds for low business volume or for not completing a year in the real estate profession.

Annual dues are payable by December 31st each year.
