Business Rules for Maine Association of REALTORS® Copyrighted Forms Access/Use

- 1. The Maine Association of REALTORS® provides forms and contracts as a member benefit through a site license with zipLogix. Any other request for a forms vendor shall be approved by the MAR Board of Directors, if the vendor can comply with these Rules and at no cost to MAR upon entering into an agreement. Access to any MAR-sanctioned forms shall only be accomplished in conjunction with MAR and its approved forms vendor(s).
- MAR-sanctioned forms shall be stored in a secure data warehouse. The MAR forms
 vendor (s) shall protect access to MAR-sanctioned forms utilizing secure login and
 verification methods.
- 3. The MAR selected forms vendor(s) will maintain the most current MAR-sanctioned forms. MAR requires that its forms vendor(s) provide MAR members with the most current MAR-sanctioned forms. MAR shall ensure that sanctioned forms are updated by its vendor(s) upon approval and release for use.
- 4. MAR requires that its members utilize up-to-date forms.
- 5. Proper use of MAR sanctioned forms is a membership duty. Only validated MAR REALTOR® members, shall be provided access to and utilize MAR-sanctioned forms. Terms for the validation and use of MAR-sanctioned forms are developed at the sole discretion of MAR. Forms may not be provided to others not authorized to obtain or use MAR forms.
- 6. The MAR forms vendor(s) shall ensure that logins are validated real-time against NRDS. Any individual not current with REALTOR® dues will be denied access to MAR-sanctioned forms.
- 7. Access to the secure data warehouse by an approved vendor on behalf of a validated MAR member requires prior authorization by MAR and strict adherence to MAR forms access/use business rules.
- 8. MAR- sanctioned forms, when printed or used electronically, shall include the REALTOR® "R" logo and Equal Housing Opportunity logo, copyright, and revision notices. In addition, a personal identifiers including REALTOR name, agency name, address, and telephone number shall be used on each page.
- 9. MAR-sanctioned forms may not be altered in any manner. For example, users are prohibited from changing fonts, editing out any part of the form or changing the length of

any data field. The forms, as used, need to be identical in all manners to the MAR-sanctioned copy.

- 10. Approved forms vendor(s) may not share or sell any data derived from any MAR-sanctioned form. This includes, but is not limited to, personal information for agents, brokers, clients, customers, or any individual involved in the real estate transaction.
- 11. In order to use MAR-sanctioned forms as part of live, online, or correspondence course materials and handouts, continuing education providers must complete the Educators Agreement for Maine Association of REALTORS® Copyrighted Forms Access/Use annually. (Appendix A to these Rules).
- 12. At its sole discretion, MAR may revoke permission for any forms use hereunder, at any time, by providing written notice (via mail or email) for violations of these Rules. In such an event, the member (s), vendor(s) or educator(s) shall immediately discontinue providing and using the forms. Failure to comply with these Rules will entitle MAR to pursue all legal remedies available for copyright violations as well as sanctions for violation of membership duties.
