VOICEMAIL GREETINGS ARE ADVERTISING:

The Maine Real Estate Commission considers your voicemail greeting (the message a consumer hears when they call your phone and you are not available) to be advertising for any phone number that you release to consumers for your real estate business. Therefore, your voicemail greetings on all phone numbers (business line that rings at your desk, cell phone, home phone) need to comply with MREC advertising rules which require your full name and the trade name of your agency as licensed.
