MAR's virtual REALTOR® Rally is tomorrow, April 15. One of the most impactful things you can do for your business is to have a voice at the Maine State House. This year, your voice can be heard from wherever you are! **We are asking you to participate in MAR's REALTOR® Rally by responding to tomorrow's CALL FOR ACTION which sends an email to your legislators.**

MAR's REALTOR® Rally CALL FOR ACTION asks legislators to:

### Support:

- MAR's remote online notarization bill;
- application for COVID-relief rental assistance by property owners (not relying on tenants to apply); and
- thanks legislators for passing MAR's LD 192 which creates a default road maintenance agreement for private roads where no agreement is in place.

### Oppose:

- a proposed new impact fee (tax) on vacant residential properties;
- an increase in the real estate transfer tax;
- eviction delays; and
- point-of-sale and annual mandates for testing air and water.
