# GUIDELINES FOR REAL ESTATE ARE STILL IN EFFECT:

More and more, we are hearing that real estate licensees are disregarding the Guidelines for Real Estate as an Essential Business, established by Maine's Department of Economic and Community Development which are still in effect. The Guidelines were established in late-May of 2020 and require cloth face coverings, one-use disposable gloves, physical distancing, and other health and safety protocols for the licensees' and clients' protection. As a real estate licensee, adherence to the State of Maine Guidelines is expected at all times and in all situations, regardless of physical location. Complaints are being filed by consumers (some with video evidence).

Here are the Guidelines in chart form for easy reference

### **CYBER/WIRE FRAUD IS HAPPENING:**

Cyber/wire fraud is happening here. We are aware of a recent incident in Maine involving more than \$150,000 that has not been recovered. Slow down, be careful and diligent, and **educate your clients**. There are lawsuits around the country against REALTORS® for money lost due to fraudulent instructions. Check with your E&O insurer to be sure you have coverage.

If you believe that you or your client are involved in a wire fraud situation:

- 1) IMMEDIATELY contact the financial institution and ask them to do a "SWIFT recall".
- 2) Contact your local law enforcement quickly (town police department or county sheriff's office) to report the incident.
- 3) Then call the FBI immediately (24 hours or less) and let them know you are reporting the incident within 24 hours. Your chances of recovery are greater with less than 24-hour reporting.
- 4) Finally, file a complaint with the FBI online at www.ic3.gov. This does not get immediate attention but is important to track serial criminals. Call the FBI, then file an online ic3 report.
