DISCLOSURE OF AGENCY COMPENSATION POLICY:

Recently, some members have been seeking clarification about one of the Disclosure of Agency Compensation Policy questions on the Exclusive Right to Sell Listing Agreement. The Maine Real Estate Commission (MREC) rule in Chapter 410 Section 6(1) states the following, in part: "If the real estate brokerage agency's policy is not to compensate all other real estate brokerage agencies in the same manner, this policy must be included in the statement and include a notice to the buyer or seller that this policy may limit the participation of other real estate brokerage agencies in the marketplace." This means that if an agency cooperates differently (i.e. offers different commission splits) with different agencies, then the company policy is that they do NOT compensate all other real estate brokerage agencies in the same manner. However, if an agency always cooperates the same (i.e. offers the same commission split) to all agencies without exception, then the company policy is that they do compensate other agencies in the SAME manner. Remember that this is a company-wide policy, not transaction specific. Every brokerage agreement for your agency should have the SAME answer. Please review your company policy with your designated broker.

Please be aware that membership is suspended if this requirement is not met and documented by midnight on 12/31/21 (end of this year!).
