COVID-19 UPDATES:

The Department of Economic and Community Development (DECD) confirmed that all of the current COVID-19 Prevention Checklists for businesses were retired on May 24, 2021, including the Guidelines for Real Estate as an Essential Business.

Please check the COVID-19 tab on the MAR website (https://www.mainerealtors.com/covid-19-resources/) for updated links to general guidance from the Maine Governor's office, Maine DECD, Maine CDC, and the U.S. CDC.

MAR recommends that each real estate company develop their own health and safety protocols as they deem necessary for the best interests of their agents, employees, and clients. Similarly, you should be cognizant of your clients' needs and requests when it comes to showings and other business interactions. Remember that not everyone around you is in the same situation as you, not everyone has the COVID-19 vaccine (including children), and some people may have underlying conditions that increase their health risk.

Please note that if a seller chooses to require any safety protocols or restrictions for showings in their home, they must be sure to treat everyone equally to avoid fair housing discrimination and have a plan in place for accommodations if requested by buyers who may be members of protected classes. Furthermore, a buyer who is a member of a protected class may request an accommodation for a showing in accordance with fair housing laws.

COVID RELIEF - PPP LOANS:

Until May 31, 2021 the Small Business Administration is offering PPP loans originated only by participating community financial institutions including Certified Development Companies (CDCs), SBA Microlenders, Community Development Financial Institutions (CDFIs), and Minority Depository Institutions (MDIs). REMINDER – SHORELAND ZONE SEPTIC INSPECTIONS:

Since January 1, 2020, Maine statute requires all septic systems located in the Shoreland Zone (not just Coastal Shoreland Zone) be inspected whenever the property is transferred. A system is exempt from the required inspection if it is less than 3 years old or has been inspected in the last 3 years by a person certified by the State of Maine. The inspection may also be waived if the buyer certifies to the Local Plumbing Inspector that a new system will be installed within 1 year. Please note that even if a buyer does not intend on selecting any due diligence contingencies when entering a P&S, the buyer is still responsible for having a septic inspection when the system is located in the shoreland zone. While the buyer is not required to make their offer contingent on the shoreland septic inspection (unless they choose to do so), the buyer is responsible for making sure the inspection is completed prior to the transfer unless the system falls into one of the three exceptions noted above.

VIRTUAL HILL VISITS:

Thank you to the 35 REALTOR® members who, along with MAR Officers Aaron Bolster, Madeleine Hill, Carmen McPhail and Sherri Dunbar met virtually and separately with Maine's U.S. Congressional delegation this week. Senator Susan Collins, Senator Angus King, Representative Chellie Pingree and Eric Kanter from Representative Jared Golden's office were asked to support federal legislation to increase housing supply, protect the 1031 like-kind exchange, safeguard the longstanding federal recognition of real estate agents to operate as independent contractors, and support legislation and increased HUD funding for testing and enforcement to ensure fair housing for all.
