

SALES DOWN AND VALUES UP IN DECEMBER:

In a press release to the media today, Maine home sales decreased -12.65% comparing December 2021 to December 2020. The median sales price (MSP) was \$303,000, a 12.22% increase in that same time period. NAR reports that existing home sales were down and prices up nationally and in the northeast, comparing December 2021 to December 2020.

SALES AND VALUES UP FOR 2021:

For calendar year 2021, Maine REALTORS® sold an historic high 20,401 homes, an increase of 2.41% over 2020. The statewide median sales price for calendar year 2021 increased 16.80% to an historic high of \$299,000. For more information, view the press release here: Click Here

DO YOU KNOW?

We are expecting around 350 legislative bills to be considered in the second session of the 130th Maine Legislature over the next three months. Some of the bills are carry-over bills (unfinished business) from last session and some are new. MAR's government affairs team reads each bill and works with the MAR Legislative Committee and MAR Board of Directors to 1) identify those bills that impact Maine's real estate industry, and 2) establish a monitor, support, or oppose priority position for each bill.

Those bills are added to MAR's "Legislative Bill Tracking Report" on a regular basis. As the session moves forward, we expect around 100 bills to be included on the tracker; potential laws that could impact your real estate business!

FORMS UPDATE: NON-DISCRIMINATION LANGUAGE:

In 2021, the following Maine law changes required MAR to update the non-discrimination language on the 2022 Buyer Agreements and Listing Agreements:

1) **Public Law Chapter 366** (LD 1688): "An Act To Improve Consistency in Terminology and within the Maine Human Rights Act" – This law addressed inconsistencies in the protections provided in different areas of jurisdiction under the Maine Human Rights Act. Of particular note for MAR's forms, the bill provides more inclusive protection by including adult family members dependent for care in the definition of "familial status" and adding gender identity to the list of protected classes.

2) **Public Law Chapter 476** (LD 1294): "An Act To Prevent Discrimination Against Domestic Violence Victims" – This law amended the Maine Human Rights Act to provide protections against discrimination in employment and housing against a person who has sought and received an order of protection after opportunity for hearing under the Maine Revised Statutes, Title 19-A, section 4007. All remedies currently available under the Maine Human Rights Act, including a private right of action and attorney's fees, are available for these persons.

The non-discrimination language in the MAR Buyer Agreements now states: "Properties shall be presented without regard to race, color, religion, sex, physical or mental disability, familial status, ancestry, sexual orientation, gender identity, or national origin as defined in Maine state law or because the person sought and received an order of protection under Title 19-A, section 4007."

The non-discrimination language in the MAR Listing Agreements now states: "Agency and Seller each agree that this property is to be offered without regard to race, color, religion, sex, physical or mental disability, familial status, ancestry, sexual orientation, gender identity, or national origin as defined in Maine state law or because the person sought and received an order of protection under Title 19-A, section 4007."
