#### **OUR ADVOCACY CONTINUES:**

MAR's government affairs team reads each bill that begins its legislative journey and works with the MAR Legislative Committee and MAR Board of Directors to 1) identify those bills that impact Maine's real estate industry, and 2) establish a monitor, support, or oppose priority position for each bill. Each priority bill is worked accordingly toward a resolution.

Those bills are added to MAR's "Legislative Bill Tracking Report" on a regular basis. Currently, MAR is tracking 120 bills with topics ranging from tax changes, impact fees on vacant residences, accessory dwelling units, permitting for the construction of affordable housing, height limitations under shoreland zoning, and more.

#### **IMPACT FEE ON VACANT RESIDENCES – LD 1337:**

We continue to urge Maine legislators to oppose LD 1337 and the amended LD 1337 "An Act to Increase Housing Availability and Improve Affordability Through a Vacancy Impact Fee". LD 1337 is an amended legislative bill that will allow municipalities to pass ordinances to impose a fee (tax) on vacant residential property not occupied by a permanent resident. The fees must be used by the municipality to increase the availability or affordability of year-round residential property within the town. Click here to read the amended bill: Click Here

The bill passed out of the Legislature's Joint Standing Committee on Taxation and had action in the Maine House of Representatives on March 9 where the bill failed 53-76. LD 1337 will have future action in the Maine Senate. Ask your Senator to vote NO on LD 1337.

A local option fee/tax based on how a homeowner uses their property is an infringement of private property rights. These homeowners have already paid a real estate transfer tax, property taxes, and a rental tax if applicable. An influx of federal pandemic relief funds has provided Maine with additional funding for the development of affordable housing. Let's utilize those funds before raising fees/taxes on Maine homeowners.
