MAR's REALTOR® Rally Call for Action asks Maine legislators to:

Support:

- Remote Online Notarization
- LD 2003: Implement the Recommendations of the Commission to Increase Housing Opportunities in Maine – Zoning and Land Use Restrictions
- LD 1084: General Fund Bond for the creation of Energy-efficient and Affordable Homes

Oppose:

- LD 1337: A proposed new local option impact fee (tax) on vacant residential properties
- LD 2199: Changes to the powers and duties of assessors

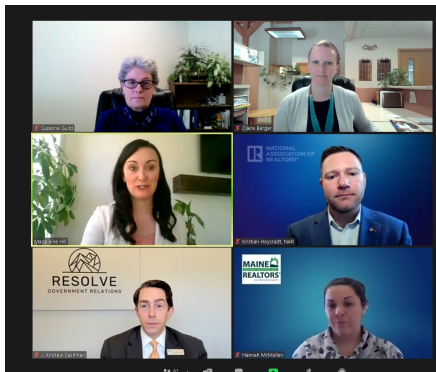
