2,123 Proposed Legislative Bills

Over the course of the 131st, our state lawmakers are slated to review a total of **2123** *legislative bill proposals* submitted by sponsored legislators and state agencies. Your MAR Legislative Committee has been busy monitoring a number of bills on *weekly tracking reports* as they relate to our industry and are released to be heard at the Legislature. It is anticipated that there will be well over 200 LD's that pertain in some capacity to housing, and or zoning/land use. After 4 weeks of



monitoring the MAR Bill Tracker already has over a 100 LDs being discussed and monitored. What's interesting and concerning is the number of "concept draft" bills. A concept draft is just as it sounds--a concept without any purposeful language behind it. It is often done in an effort to refine the language at a later date, or to essentially hold a spot as the idea is further developed. Either way, the number of concept drafts being put forth is seemingly a historic amount. You can review the tracking reports at our website which are updated regularly. MAR testifies on any bill with a 1-3 support, oppose or Neither For Nor Against (NFNA). We do not testify on any bills that are 2M, 3M, or 4's.

What's on the Agenda?

We have been seeing and hearing about many municipalities suggesting Rental Registry, Moratoriums, Short Term Rental Ordinances/Fees and more. Be sure you are checking your local government's meeting details and reading the agenda to ensure you are a part of the conversations and not left in the dark! MARPAC-- or "Maine Association of REALTORS® Political Action Committee

is a wholly owned subsidiary corporation of MAR. It is our advocacy warrior that aids in endorsing champions of real estate who help protect private property rights, fair tax laws and balanced economies. Each REALTOR® member can opt (or opt out) of a voluntary investment in MARPAC at any time and for any amount. Our endorsement and advocacy is guided by our *Public Policy Statement* and is neither BLUE or RED, but rather PURPLE, for REALTOR® party issues that the membership choose to include in our PPS. MARPAC investments keep 70% of funds in state to work on statewide advocacy measures and 30% goes to *NAR* to work on our behalf federally. At the local association level, MARPAC has aided when asked and continually works toward keeping our *industry relevant and sustainable in an every changing economy and political environment*.


MARPAC is tightly governed by strict campaign finance law in Maine, so each investment is closely managed along with MAR staff and their time spent along with reporting obligations.
