The deadline is May 15 if you would like to request an appointment to a 2024 National Association of REALTORS® Committee. NAR Committees will meet in May and November 2024 at the national REALTOR® meetings (in DC and Boston). There are currently 17 Maine REALTORS® serving on NAR committees during 2023.

Please note: NAR committee applications are completed online.

Step 1: you must create/update an Expertise Profile on NAR.realtor;

Step 2: you can apply for up to five NAR committee appointments;

Step 3: you may seek endorsements/recommendations for your applications (which is important to do).
