TODAY - please participate in the virtual portion of the Maine Association of REALTORS® Rally by responding to the Call for Action and TAKE ACTION which



sends an email to your legislators. If you can't remember if you responded, please try again. The system won't let you take action twice.

HOW TO TAKE ACTION:

1.) From Your In-box: Find the email that was sent to you at 8:00 a.m. yesterday morning (April 6) with "Take Action" in the subject line. The email was sent from the Maine Association of REALTORS® (claire@mainerealtors.com). Click on the TAKE ACTION button and then "Send Message" on the right-hand side.

2) Can't Find the Email?

- a) Visit our Rally website
- b) Click on the TAKE ACTION button/link at the top

c) Add your name and home address on the bottom right side of the page. Your Maine legislators' contact information will autopopulate and send.

d) You may be sent an authentication code to your email to enter to verify your email address.

e) Remember to click on the "Send Message" at the bottom – and your voice has been heard!

MAR's REALTOR® Rally Call for Action asks Legislators to: Support:

 LD 226 and LD 1074 for the development of affordable housing

Oppose:

- LD 804 which would increase the notice period to terminate a tenancy at will
- LD 557 eviction history could be considered discriminatory
- LD 214 and LD 1154 which weaken PL 672 (ADU's and zoning reform)
- LD 843 and LD 667 which increase Maine's income tax for certain income brackets

ARTICLE 10: Article 10 of the NAR Code of Ethics states: Realtors® shall not deny equal professional services to
