REMINDER – SHORELAND ZONE SEPTIC INSPECTIONS

Since January 1, 2020, Maine statute requires all septic systems located in the Shoreland Zone (not just Coastal Shoreland Zone) be

inspected whenever the property is transferred. This requirement applies whenever any portion of the septic system is in the shoreland zone, including septic tanks, drainage fields, and holding tanks. A system is exempt from the required inspection if it is less than 3 years old or has been inspected in the last 3 years by a person certified by the State of Maine. The inspection may also be waived if the buyer certifies to the Local Plumbing Inspector that a new system will be installed within 1 year. Please remember that even if a buyer does not intend on selecting any due diligence contingencies when entering a P&S, the buyer is still responsible for having a septic inspection when the system is located in the shoreland zone.

While the buyer is not required to make their offer contingent on the shoreland septic inspection (unless they choose to do so), the buyer is responsible for making sure the inspection is completed prior to the transfer unless the system falls into one of the three exceptions noted above. Please note that municipalities may have additional ordinances relating to shoreland zone septic inspection requirements (including fines for violations) so it is good idea to check with the local plumbing inspector or code enforcement officer on what the municipality requires before the closing.
