



#### SALES DOWN AND VALUES UP IN SEPTEMBER:

In a press release to the media today, Maine home sales decreased -25.40% comparing September 2023 to September 2022. The median sales price (MSP) was \$376,750, a 14.17% increase in that same time period. NAR

#### MAR FORM REMINDER – SELLER'S PURCHASE/LEASE OF PROPERTY ADDENDUM:

If you have a seller who needs to find housing before they can sell their property,

please review and consider using the **Seller's Purchase/Lease** of Property Addendum. I have received many recent inquiries from agents who do not realize this form is available in ZipForms. I generally advise against agents trying to draft a "suitable housing" clause in the P&S because there are often questions and disputes that arise later about the conditions and timeframes surrounding that contingency. Instead, it is in your client's best interest to use the Seller's Purchase/Lease of Property Addendum which contains more detail about terms of the contingency. If your client is looking for something specific to add to a P&S that is not addressed in the addendum, they should consult with a real estate attorney for drafting that language.

Your 2024 REALTOR® dues invoices are available now, and have a deadline in December. (Greater Portland Board and MidCoast Board are due on December 1)

and local board late fees may be assessed beginning in early-December – as early as December 2. You pay your dues through your local REALTOR® boards' Member Portal (links in right margin).

Designated Brokers: Remember...dues must be paid for anyone licensed in a REALTOR® office as of January 1, 2024. If an agent plans to make their license status inactive or his/her
