#### **NATIONAL FLOOD INSURANCE PROGRAM EXTENDED:**

Thank you to those who responded to NAR's Call for Action last week regarding the National Flood Insurance program. The U.S. Congress and the President signed a Continuing Resolution through November 17, 2023 to keep the federal government, including the NFIP operational.

#### **EVERY MONTH IS SAFETY MONTH!**

The Maine Association of REALTORS® has been notified that a woman, claiming to have Parkinsons Disease and using a walker, is in Maine (from Maryland) searching for homes in southern Maine as a cash buyer. She is vague/changes her story about her exact location in Maine and lacks her own transportation. A York County REALTOR® picked her up at an agreed-upon location and showed her 4 properties, with the woman stating that she would show proof of funds with an offer after going to the bank the next morning.

A later search on Forewarn and Google showed that the woman has an extensive criminal history including armed robbery, fraud, forgery, and theft in other states. There has been no additional communication since the showings. The agent contacted law enforcement.

For prospective sellers who are not physically located near you/the property, ask them to Zoom, Google Meet, Facetime with you for a first meeting – and ask them to show their identification on the screen. While scammers may also have fraudulent identification, they are likely to be unwilling to show their face on a screen.

For potential sellers who are nearby, always schedule first meetings with customers/clients in the office, verify their identity (take a photo of their driver's license), and introduce them to a colleague. You can use a phrase like, "it's our office protocol for new customers and clients". If they're unwilling, likely a red flag.

When showing a home, accompany the potential buyers at all times, and always have your prospect walk in front of you. Don't lead them, but rather, direct them from a position slightly behind them for your physical safety and for the security of the premises.

Safety comes first, trust your instincts, and let law enforcement and your colleagues know about any suspicious and unsettling interactions. Always.

#### 4 Things You Can Do:

- Think Before You Click: Recognize and Report
   Phishing: If a link looks a little off, think before you click.
   It could be an attempt to get sensitive information or install malware.
- <u>Update Your Software:</u> Don't delay -- If you see a software update notification, act promptly. Better yet, turn on automatic updates.
- <u>Use Strong Passwords:</u> Use passwords that are long, unique, and randomly generated. Use password managers to generate and remember different, complex passwords for each of your accounts. A passwords manager will encrypt passwords securing them for you!
- Enable Multi-Factor Authentication: You need more than a password to protect your online accounts, and enabling MFA makes you significantly less likely to get hacked.
