

# **New Maine Laws- What You Need to Know:**

On October 25th, *some 450 laws were enacted* 90 days post first session of the 131st.



- LD 1706: ADU laws clarity and implementation pushed to 7/1/2024
- LD 701: Increased rental increase notice period to 75 days IF rental increase is 10% or more.
- LD 470: Continued support of the lead abatement program through MSHA
- LD 1931: Amended laws regarding Mobile Home Park Sales
- LD 1306: Protections against the "40-year listing agreement"

# It's feeling a bit like spring training now- a few game time plays but the anticipation of the full season is upon us!

The Maine legislature is preparing to ramp back up for the second session of the 131st on January 3, 2024, and there is quite a list of bill titles that will discussed, some even seeing action in committee in advance of January!

MAR last session tracked over 400 bills and of our top priority bills, 22 were carried over and will be heard in the second session. A few examples of the top issues:

Intertidal Zone, State-wide Rental Registries, Housing Provider and Tenant Relationships, PFAS testing, Barriers and Solutions

# What did we do over "Summer Vacation"? The advocacy party didn't stop!

Since adjournment in July, the MAR Government Affairs team has continued to advocate on behalf of our members and property owners statewide:



- Provided public comments encouraging increased
  information sharing and the delayed implementation
  regarding *Proposed Sand Dune Map Updates* that would impact private property rights,
  values and real estate. *Learn more about the new maps here*
- Gave support to local member advocates on a number of municipal ordinance discussions: (here are two examples)

**Old Orchard Beach:** Thank you to those whose grassroots advocacy work proved effective as they spoke out against a proposed Short-Term Rental (STR) Moratorium that would have greatly restricted private property use. *The proposal was withdrawn. GREAT WORK!* 

**Augusta:** Rental Licensing Ordinance, requiring registered properties to pay \$100 per unit, steep fines if failure to register, at/will code enforcement inspections, possible displacement of tenants based on inspection findings. KVBR members and city-wide housing providers attended and spoke out against these measures providing reasonable solutions to concerns regarding health and safety. Read the proposed ordinance and learn about the recent Public Hearing held on October 24th, Thank you to those that attended and advocated!

Recently, the Maine Secretary of State release some interesting statistics about voter turnout:

In 2022 Maine ranked #1 nationally in voter turnout. 73.3% of total registered Maine voters took to the polls last November. Compared to 2018, that was an almost 2% increase. *Way to go!*
