COVERME.GOV:

The Made for Maine Health
Coverage Act, passed by the Maine
Legislature in 2020, authorized the



creation of a State-run health care insurance marketplace where individuals and families can shop for health insurance. Maine's Marketplace, called CoverME.gov is now open. All plans sold through CoverME.gov provide comprehensive coverage and Essential Health Benefits.

The Open Enrollment Period closes on January 16, 2024. You can use https://CoverME.gov to:

- Shop for and compare health insurance plans that provide quality comprehensive coverage.
- Apply for financial assistance to lower health insurance costs.
- Find a certified expert to guide you through the shopping and enrollment process and answer your questions at no cost to you.
